5. Adoption of the Audited Financial Statements for the year ending 31 December 2014.

Rowing Queensland Ltd. is in a very solid financial position. As a brief summary of the accounts, we draw your attention to the following components of the audited financial report.

2014 financial accounts have been audited in line with the Act by Morris & Batzloff.

- Revenues from Ordinary Activities returned a \$1,512 surplus in 2014.
- Income was \$87,935 more than 2013 The major items were an additional grant, carry over from the Jobs Plan program and equipment grant, Pan Pac Games and income from regattas
- Expenditure was \$119,255 more than 2013 Major item was the employment was higher due to commencement of the Sport Development Manager, this position was vacant for 6 months in 2013; and
- Administration slight increase in expenses. This was due to legal costs associated with an appeal regarding transition from Incorporated Association to Company and a member protection investigation matter.

No questions were raised from the floor.

No concerns to these appointments were raised from the floor.

The scrutineers returned and provided the Chair with the outcome of the election of officers. There were a total of 30 votes cast. The Chairman announced the outcome of the ballot.

S. Newcomb wished to publicly thank the RQ staff for their assistance provided to him in setting up the Ipswich Rowing Club. One school will soon commence a land based rowing program until the club has a shed and equipment to work from. Any clubs wishing to get rid of any old boats were asked to consider Ipswich RC first.

The CEO announced that the Wide Bay RC based in Maryborough have recently affiliated with RQ and that communication has commenced with RQ in establishing a rowing club in Stanthorpe
